3. BOD Oversight of the Executive Board

The BOD of the Corporation regularly oversees the activities of the CEO and other management personnel in performing their assigned duties and responsibilities, based on the Corporation's Charter of Organization and Operation and the Regulations on the Organization and Operation of the Corporation's BOD. The BOD refrains from direct intervention in the CEO's operational duties, supporting the CEO in effectively implementing resolutions and decisions from the General Meeting of Shareholders and the BOD.

3.1. Oversight in the first six months of 2025

The business and production activities of the Corporation during the first six months of 2025 took place in the context of: (i) Globally: Heightened geopolitical tensions; economic uncertainty stemming from U.S. tariff policies that have posed a threat to the recovery of the global economy; and decisions by the OPEC+ alliance regarding crude oil output, which contributed to a continued decline in global oil prices for most of the first half of 2025. In June 2025, the outbreak of conflict between Israel and Iran caused a sharp surge in oil prices; however, following a 12-day confrontation that ended with a ceasefire agreement between the two parties, oil prices once again reversed and trended downward; and (ii) Domestically: Despite the persistent risks associated with U.S. tariff policies and global tensions, the Vietnamese economy maintained a stable growth trajectory. Market risks were effectively managed, and enterprises continued to receive support.

For key petroleum trading enterprises in general, and PVOIL in particular, business and production activities during the first half of 2025 faced significant challenges due to the impact of global oil price fluctuations, foreign exchange rate volatility, and a partial decline in fuel consumption demand driven by the growing trend of electric vehicle adoption. In light of these circumstances, the BOD of PVOIL closely monitored the Corporation's operations, kept abreast of market developments, provided timely and appropriate guidance, and actively supported the Executive Management Board in the administration of business and production activities.

- **Production and Business:** directed, urged progress, and exercised oversight over the implementation of the business and production plan for the first half of 2025; prioritized the analysis and forecasting of global oil prices to ensure a stable fuel supply for the market;

leveraged the advantages of the integrated value chain; and focused on solutions aimed at increasing revenue, business volume, and expanding market share.

- **Financial Management and Debt Oversight:** provided guidance and oversight to ensure the financial health of the PVOIL system; implemented effective and secure cash flow management; strengthened debt management practices; exercised strict cost control, promoted savings, and prevented wastefulness; and enhanced supervision and evaluation of the efficiency of external capital investments.

- **Investment and Construction:** directed and oversight to accelerate the implementation progress of investment projects planned for 2025, including: investment in the development of petroleum stations and storage facilities; investment in infrastructure to support the deployment of new product lines; and expediting the progress of carry-over projects from previous years.

- **IT Applications and Digital Transformation:** directed continued efforts to comprehensively promote the application of information technology, automation, and digital transformation across all business and production activities, with the aim of enhancing operational efficiency and corporate governance, as well as diversifying business models; simultaneously, emphasis was placed on strengthening digital transformation training for PVOIL's leadership and key management personnel, along with implementing AI-related training programs for staff.

- **Organizational Structure, Labor, and Salary:** provided guidance on matters related to personnel management within its authority of BOD, promoted the reform and improvement of the organizational structure of subsidiary units; directed the development and approval of staffing norms, labor utilization, and salary plans for 2025; and ensured the completion of the 2024 actual payroll fund settlement for the Corporation and its subsidiaries.

- **Corporate Governance:** continued to oversee the review, revision, supplementation, and completion of the Corporation's internal policies and regulations to ensure compliance with applicable laws, decrees, and newly effective governmental regulations, as well as alignment with the Corporation's operational realities; studied and initiated the implementation of enterprise risk management in accordance with the COSO-ERM framework; enhanced customer service quality at petroleum stations and depots; implemented solutions to ensure cybersecurity and information safety; strengthened system governance and promoted the development of scientific research projects and the application of information technology in management and operations to improve overall efficiency; and reinforced fire prevention and control measures, occupational safety, and hygiene-particularly at depots and petroleum stations.

- **Enterprise Restructuring and Innovation:** continued to direct the implementation of the restructuring and reorganization plan for PVOIL for the 2020–2025 period; oversaw the reorganization of subsidiary units, the restructuring of biofuel plants, and the finalization of equitization settlements; and continued to pursue the divestment of

capital from non-core businesses.

- **Completion of Legal Documentation for Land and Attached Assets:** Direct the system to focus on reviewing and completing legal documentation for assets related to land and structures attached to land.

- **Biofuel Projects:** Continue collaboration with shareholders of BSR-BF, OBF, and PVB to implement solutions for biofuel projects as directed by authorities and in compliance with legal procedures; Regularly update information on these projects and report to relevant authorities as required.

- **Inspection and Supervision:** organized close supervision of the business and production activities of all units within the system; provided direction on support measures and remediation plans for underperforming units, including those with accumulated losses or subject to special monitoring; directed the implementation of corrective actions to address existing shortcomings identified by both external and internal inspection and audit teams; and strengthened the direct oversight role of the Corporation's Board of Directors over the operations of affiliated units across the system.

- **Development Orientation and Strategic Planning:** continued to provide guidance aligned with the development orientation of the petroleum industry and the realities of the ongoing energy transition, in order to timely review, adjust, and supplement PVOIL's business and production strategy and plans accordingly; further directed the formulation of the business and investment development plan for the 2026–2030 period, the corporate development strategy toward 2030, with a vision to 2050; and studied and initiated the development of new business lines and products in alignment.

- **Corporate Communications, Corporate Culture, and Social Welfare:** provided direction and oversight to ensure that communication efforts were carried out in a comprehensive and consistent manner, closely aligned with strategic objectives to promote PVOIL's image and brand; guided the development of a corporate culture that reflects PVOIL's mission and strategic vision, incorporating elements of digital transformation and energy transition into business operations, communications, and corporate culture; and directed the organization of various initiatives to support the physical and mental well-being of employees and the broader community, including the provision of financial support for select healthcare and social welfare programs at hospitals and localities across the country.

- **Coordination Efforts:** Maintain close and effective collaboration between the Board of Supervisors and the Board of Management in implementing resolutions of the General Meeting of Shareholders and the BOD. In order to strengthen the coordination of activities, the BOD directed the development of regulations on coordination between the BOD, CEO and the Board of Supervisors. The BOD supervised compliance with laws and internal regulations in managing and operating the Corporation. Resolutions/decisions issued by the BOD were promptly sent to the CEO and notified to the Board of Supervisors. The implementation of resolutions/decisions of the BOD was regularly monitored, periodically reviewed and evaluated.

3.2. Supervision Results

The Board of Management effectively and fully performed the assigned functions and tasks, managing the production and business operations of the Corporation in line with the goals and directions set by the General Meeting of Shareholders and the BOD.

- In the first half of 2025, the Corporation exceeded its planned targets for petroleum sales volume and revenue; however, the profit target was not achieved due to unfavorable fluctuations in global oil prices.

- The Corporation effectively implemented integrated value chains within the industry; ensured stable and well-coordinated supply operations, securing sufficient product availability across the Corporation's distribution network; closely monitored market trends and oil price movements to maintain optimal inventory levels, thereby minimizing risks and safeguarding business performance in the event of sharp oil price declines.

- Investment in the development of petrol stations through various forms was actively promoted and yielded positive results in the first six months of 2025.

- The restructuring of member units continued as scheduled, with the units successfully merged quickly stabilizing their organizations, focusing on business activities, and achieving good results.

- Digital transformation, ERP implementation, and the application of Industry 4.0 technologies continued to be vigorously promoted, enhancing corporate governance and competitiveness through the execution of Projects 1114 and 808, professional skill competitions, and the deployment of digital platforms supporting business operations. Security, safety, and fire prevention and control measures were effectively maintained, while cybersecurity was tightly managed and monitored.

- Efforts to expand the scope of new product sales based on the extensive network of petrol stations and terminals across the country were made, actively seeking partners and forms of cooperation to implement non-oil services and introduce new business offerings.

- Social and community activities, including charity and welfare work, were actively implemented throughout the system, with many meaningful initiatives.

Overall, in the management and administration of the Corporation's operations, the CEO and the management team complied with all relevant legal regulations; fully performed their functions and duties as stipulated in the Charter and the Corporation's internal governance regulations; thoroughly and seriously implemented the resolutions and decisions of the General Meeting of Shareholders and the Board of Directors regarding the business plan and restructuring efforts; operated the Corporation in line with the approved strategic orientation; strictly adhered to regulations on information disclosure applicable to public companies; and made every effort to achieve the best possible business results for the first six months of 2025.

Division under its direct supervision. Its role is to advise and assist the BOD in the inspection, auditing, and monitoring of the system's operations.

In the first six months of 2025, the Board of Supervisors convened meetings to implement its 2025 activity plan, assigning specific tasks for monitoring subsidiary units and overseeing the implementation of the business and production plan of the Corporation and its affiliated entities.

3. Supervision Activities of the Board of Supervisors toward the BOD, BOM, and Shareholders

3.1. Activities of the Board of Directors

- The Board of Directors implemented the resolutions of the General Meeting of Shareholders and convened multiple meetings, with official minutes recorded, as well as conducted written consultations to issue resolutions and decisions aimed at managing and directing the Corporation's operations across various areas of activity.

- The Board of Directors has carried out its roles and responsibilities in accordance with the Law on Enterprises and the Corporation's Charter; it has consistently directed the BOM to implement the resolutions and decisions of both the General Meeting of Shareholders and the Board of Directors.

- The Board of Directors actively directed efforts in digital transformation, enhanced service quality, and promoted the reform of labor and salary management policies.

3.2. Activities of the CEO

- The CEO consistently directed functional departments, affiliated units, and member companies to implement tasks in accordance with internal management regulations, the Corporation's Charter, resolutions and decisions of the Board of Directors and the General Meeting of Shareholders, as well as other applicable legal provisions.

- The CEO actively sought solutions to address challenges and obstacles in the Corporation's business and investment activities, both at the corporate and subsidiary levels,

and took decisive action in directing the preparation for the commencement of Jet A1 aviation fuel business operations.

- Market conditions during the first half of the year were particularly unfavorable, with oil prices and petroleum product prices continuously declining, posing significant challenges to distribution activities, sourcing, and inventory management. However, thanks to PVOIL's capabilities, experience, and its flexible and prudent business and inventory management policies, the Corporation not only avoided losses but also achieved profitability during the first six months of the year.

- PVOIL continued to maintain close collaboration with units within the Group to effectively implement the integrated value chain of feedstock supply – production – storage and distribution in the fields of crude oil and petroleum products, in coordination with industry partners such as PV GAS, BSR, PVNDB, among others. These efforts contributed positively to the overall business and production performance of the Corporation in 2025.

3.3. For Shareholders

The Board of Supervisors consistently and diligently carried out its activity plan as approved by the General Meeting of Shareholders. At the Shareholders' Meeting, The Board of Supervisors reported on matters in accordance with regulations and provided observations, evaluations, and recommendations aimed at continuously improving corporate governance, inspection, and oversight within the Corporation.

4. Coordination Between the Board of Supervisors, BOD, CEO, and Other Management Personnel

The Board of Supervisors maintained close and regular coordination with the Board of Directors and the General Director in fulfilling its assigned roles and responsibilities. It engaged in ongoing dialogue to understand and clarify matters prior to providing official opinions. The BOD/CEO frequently invited The Board of Supervisors to attend key meetings and consistently supported and facilitated the effective operation of The Board of Supervisors.

5. Other Activities of the Board of Supervisors (if applicable)

The Board of Supervisors coordinated with the Corporation's leadership during internal audit missions to review the compliance of PVOIL's appointed representatives at subsidiary units.
